Safety incidents


This has become an area of concern of late and will need action in the form of awareness and/or Toolbox talks.

On the 2nd of January this year, we held a safety day at a number of our sites.

This year, plant staff were invited to carry out their own vehicle inspections.

Across the tipper region, we managed to audit one hundred plus eight wheelers, artics and walking floors, all in the space of an afternoon.

Common findings for vehicle audits:

- Camera system. Requirement is 360 degree imagery
- Audible alert for vehicle turning left
- Wheel nut indicators

- · Al driver distraction safety alerts




